WEDDING THEME: PLEASE SPECIFY TRADITIONAL / FORMAL / INFORMAL / CASUAL ETC.

**PHOTOGRAPHY FEE: \$1700.** A SECURITY DEPOSIT OF \$100 IS DUE AT THE SIGNING OF THIS AGREEMENT. AN ADDITIONAL SECURITY DEPOSIT PAYMENT OF \$325 (DEPOSIT TOTALING \$425 - 25% OF PACKAGE PRICE) IS TO BE PAID 30 DAYS PRIOR TO THE WEDDING. THE REMAINING BALANCE OF \$1275 IS TO BE PAID BY THE DATE OF THE WEDDING.

**EXPENSES:** IF TRAVEL IS REQUIRED THE CLIENT IS RESPONSIBLE FOR ALL TRAVEL, ACCOMMODATION, MEAL AND TRANSPORTATION COSTS UNLESS PROVIDED BY THE CLIENT. RECEIPTS WILL BE PROVIDED BY NOAHFOTO FOR ALL BILLABLE EXPENSES.

**WEDDING PACKAGE AND SERVICES INCLUDED FOR THE FEE STATED ABOVE:**

- UNLIMITED PHOTOGRAPHY COVERAGE WITH TWO PHOTOGRAPHERS.
- 300 WEDDING PHOTOS DELIVERED DIGITALLY SELECTED BY NOAHFOTO.
- WRITTEN AND SIGNED LIMITED COPYRIGHT RELEASE FORM FOR THE 300 WEDDING PHOTOS.
- ONE 10 X 10 INCH LEATHER FLUSH MOUNT WEDDING ALBUM WITH 10 PAGES (20 SIDES).
- TWO 8 X 8 INCH COFFEE TABLE STYLE WEDDING ALBUMS WITH 10 PAGES (20 SIDES).
- LABOR FOR PHOTOGRAPHIC POST PROCESSING AND ALBUM DESIGN.
- ALBUM PROOFS WILL BE PRESENTED TO THE CLIENT FOR APPROVAL BEFORE FINAL PRINTING.

**ENTIRE AGREEMENT:** THIS AGREEMENT CONTAINS THE ENTIRE UNDERSTANDING BETWEEN NOAH MICHEAL PHOTOGRAPHY (NOAHFOTO) AND THE PARTY REQUESTING PHOTOGRAPHY SERVICES (CLIENT). IT SUPERSEDES ALL PRIOR AND SIMULTANEOUS AGREEMENTS BETWEEN THE PARTIES. THE ONLY PROCESS TO CHANGE OR ALTER THIS AGREEMENT IS TO DO SO IN WRITING, SIGNED BY ALL PARTIES. IF THE PARTIES AGREE TO WAIVE ONE PROVISION OF THIS AGREEMENT THAT DOES NOT IMPLY THAT ANY OTHER PROVISION IS ALSO WAIVED. THE PARTY AGAINST WHOM A WAIVER IS SOUGHT TO BE EFFECTIVE MUST HAVE SIGNED A WAIVER IN WRITING.

**RESERVATION:** A SIGNED CONTRACT AND SECURITY DEPOSIT ARE REQUIRED TO RESERVE SPECIFIED COVERAGE.

**PRE-EVENT CONSULTATION:** THE PARTIES AGREE TO A PRE-EVENT CONSULTATION BEFORE THE EVENT DATE IN ORDER TO FINALIZE THE ACTUAL SHOOTING TIMES, LOCATIONS, AND CLIENT'S REQUEST LIST (IN WRITING) FOR SPECIFIC PHOTOGRAPHS.

**COOPERATION:** THE PARTIES AGREE TO CHEERFUL COOPERATION AND COMMUNICATION TO ENSURE THE BEST POSSIBLE RESULT WITHIN THE DEFINITION OF THIS AGREEMENT. NOAHFOTO RECOMMENDS THAT CLIENT DESIGNATE A FAMILY MEMBER TO ACT AS AN "EVENT GUIDE" TO POINT OUT IMPORTANT INDIVIDUALS TO THE PHOTOGRAPHER DURING THE WEDDING AND GATHER FAMILY MEMBERS TOGETHER FOR FORMAL PORTRAITS. THE PHOTOGRAPHER WILL NOT BE HELD ACCOUNTABLE FOR NOT PHOTOGRAPHING DESIRED INDIVIDUALS IF THERE IS NO "EVENT GUIDE" TO ASSIST IN IDENTIFYING INDIVIDUALS AND GATHERING PEOPLE FOR PHOTOGRAPHS. NOAHFOTO IS NOT RESPONSIBLE IF KEY INDIVIDUALS FAIL TO APPEAR OR COOPERATE DURING PHOTOGRAPHY SESSIONS.

**SHOOTING TIME / ADDITIONS:** THE PHOTOGRAPHY SCHEDULE AND SELECTED METHODOLOGY ARE DESIGNED TO ACCOMPLISH THE GOALS AND WISHES OF THE CLIENT IN A MANNER ENJOYED BY ALL PARTIES. SHOOTING WILL COMMENCE AT THE SCHEDULED START TIME. ADDITIONAL PHOTOGRAPHY COVERAGE IS AVAILABLE TO THE CLIENT AT A RATE OF \$100 PER HOUR.

**HOUSE RULES:** THE PHOTOGRAPHER IS LIMITED BY THE GUIDELINES OF THE CEREMONY OFFICIAL OR RECEPTION SITE MANAGEMENT. CLIENT AGREES TO ACCEPT THE TECHNICAL RESULTS OF THEIR IMPOSITION ON THE PHOTOGRAPHER. NEGOTIATION WITH THE OFFICIALS FOR MODERATION OF GUIDELINES IS CLIENT'S RESPONSIBILITY; NOAHFOTO WILL OFFER TECHNICAL RECOMMENDATIONS ONLY.

**COPYRIGHTS:** UNTIL FINAL PAYMENT FOR SERVICES RENDERED IS MADE, THE PHOTOGRAPHS PRODUCED BY NOAHFOTO ARE PROTECTED BY FEDERAL COPYRIGHT LAW (ALL RIGHTS RESERVED) AND MAY NOT BE REPRODUCED IN ANY MANNER WITHOUT NOAHFOTO EXPLICITLY WRITTEN PERMISSION. UPON FINAL PAYMENT BY THE CLIENT, LIMITED COPYRIGHT OWNERSHIP OF THE RESULTING IMAGES INCLUDED IN THE PACKAGE WILL BE TRANSFERRED TO THE CLIENT UNDER THE FOLLOWING CONDITIONS:

THE DIGITAL NEGATIVES ARE PROPERTY OF CLIENT FOR PERSONAL USE AND FOR THE PURPOSES OF THE REPRODUCTION AND TRANSMISSION OF PHOTOGRAPHS TO FRIENDS AND RELATIVES.

THE CLIENT MUST OBTAIN WRITTEN PERMISSION FROM AND COMPENSATE NOAHFOTO PRIOR TO THE CLIENT OR ITS FRIENDS AND RELATIVES PUBLISHING OR SELLING THE PHOTOGRAPHS FOR PROFIT.

**EXHIBITION:** CLIENT GRANTS NOAHFOTO PERMISSION TO DISPLAY IMAGES RESULTING FROM THIS ASSIGNMENT AS AN EXAMPLE OF NOAHFOTO'S WORK AND FOR ENTRANCE INTO PHOTOGRAPHIC COMPETITIONS AND RELEASE ALL CLAIMS TO PROFITS THAT MAY ARISE FROM USE OF IMAGES.

**MODEL RELEASE:** THE CLIENT HEREBY GRANTS TO NOAHFOTO AND ITS LEGAL REPRESENTATIVES AND ASSIGNS, THE IRREVOCABLE AND UNRESTRICTED RIGHT TO USE AND PUBLISH PHOTOGRAPHS OF THE CLIENT OR IN WHICH THE CLIENT MAY BE INCLUDED, FOR EDITORIAL, TRADE, ADVERTISING AND ANY OTHER PURPOSE AND IN ANY MANNER AND MEDIUM; TO ALTER THE SAME WITHOUT RESTRICTION; AND TO COPYRIGHT THE SAME. THE CLIENT HEREBY RELEASES NOAHFOTO AND ITS LEGAL REPRESENTATIVES AND ASSIGNS FROM ALL CLAIMS AND LIABILITY RELATING TO SAID PHOTOGRAPHS.

**LIMIT OF LIABILITY:** IN THE UNLIKELY EVENT THAT THE PHOTOGRAPHER IS INJURED OR BECOMES TOO ILL TO PHOTOGRAPH THE EVENT, NOAHFOTO WILL MAKE EVERY EFFORT TO SECURE A REPLACEMENT PHOTOGRAPHER. IF THE SITUATION SHOULD OCCUR AND A SUITABLE REPLACEMENT IS NOT FOUND, RESPONSIBILITY AND LIABILITY IS LIMITED TO THE RETURN OF ALL PAYMENTS RECEIVED FOR THE EVENT PACKAGE. NOAHFOTO TAKES THE UTMOST CARE WITH RESPECT TO EXPOSURE, TRANSPORTATION, AND PROCESSING THE PHOTOGRAPHS. HOWEVER, IN THE UNLIKELY EVENT THAT PHOTOGRAPHS HAVE BEEN LOST, STOLEN, OR DESTROYED FOR REASONS WITHIN OR BEYOND NOAHFOTO'S CONTROL, NOAHFOTO'S LIABILITY IS LIMITED TO THE RETURN OF ALL PAYMENTS RECEIVED FOR THE EVENT PACKAGE.

**SECURITY DEPOSITS:** IN THE EVENT OF CANCELLATION, THE SECURITY DEPOSIT PAID MAY BE PARTIALLY REFUNDABLE. THE PORTION OF THE DEPOSIT THAT SHALL BE LIQUIDATED DAMAGES TO NOAHFOTO IN THE EVENT OF A BREACH OF CONTRACT BY CLIENT ACCORDING TO THE FOLLOWING SCHEDULE:

**LIQUIDATED DAMAGES SCHEDULE (CANCELLATION FEE):**

- \$50 - MINIMUM FEE FOR CANCELATION AT ANY TIME
- \$100 - CANCELLATION WITHIN 90 DAYS OF WEDDING
- \$425 - CANCELLATION WITHIN 30 DAYS OF WEDDING

THE CLIENT SHALL ALSO BE RESPONSIBLE FOR PAYMENT FOR ANY NOAHFOTO CHARGES INCURRED UP TO TIME OF CANCELLATION SUCH AS TRAVEL, LODGING, ETC. WEDDING RESCHEDULING CONSTITUTES A BREACH OF CONTRACT BY THE CLIENT. HOWEVER, IF NOAHFOTO PROVIDES THE PHOTOGRAPHY SERVICE FOR THE RESCHEDULED WEDDING, THERE WILL BE NO CANCELLATION FEE IMPOSED ON THE CLIENT.

**COMPLETION SCHEDULE:** POST PROCESSING AND CD CREATION TO BE COMPLETED WITHIN 4 WEEKS. ALBUM COMPLETION WITHIN 8 WEEKS.

**PAYMENT SCHEDULE:** \$100 SECURITY DEPOSIT DUE AT TIME OF SIGNING OF AGREEMENT. \$325 (TOTALING 25% OF THE PACKAGE PRICE) AT 30 DAYS PRIOR TO THE WEDDING. \$1275 BALANCE PAYABLE IN FULL AT TIME OF WEDDING.
